Risk Analysis

CynergisTek will lead your organization through an appropriately-scaled risk assessment process based on your past and current efforts in this area. If there is evidence of an active risk management program, an Independent Verification and Validation (IV&V) may be all that is required. If risk assessment consistent with the NIST standard has not been performed in the last 18 months, an in-depth risk assessment will be performed.

EHR Application(s) Security Configurations

CynergisTek will lead your organization through a detailed review of the security feature/functionality and controls for each application comprising your EHR. We will verify and validate that these controls have been implemented, and recommend corrective action if controls can be optimized. If or when functionality has not been enabled by design, we will document these exceptions and the rationale for them.

EHR Access Control and Access Management

While we await final guidance on limited data set and minimum necessary, we know that we are trending toward more thoughtful and restrictive approaches ePHI access. CynergisTek will lead your organization through a detailed review of access control/access management policies, EHR application access controls (to the extent they exist) and technologies that support access to the EHR (e.g. provisioning solutions, simplified sign-on, active directory).

An effective auditing and monitoring program is paramount to ensuring the effectiveness of your MuSec and overall IT security posture. Safe Harbor Readiness
